### SHORT DESCRIPTION

Jacket:

Material: 100 % Polyamide, coated with Polyurethane, washable with 40 °C.

Type and description: Jacket in raglan design, with high visible colour on the breast and the back; arm width

adjustable, welded seams, concealed zipper, ventilation in the armpit and at the back side, stand-up collar with hood, 2 colours available: orange-blue, orange-olive. The whole suit is tested in accordance with DIN EN 343 class 3 (of 3) for water repellence and class 2 (of 3)

for water vapour resistance (breathability) of the jacket resp. 1 of the trousers.
